## DEER HUNTING INFORMATION - 1993

Limited deer hunting will be allowed on Parker River Refuge by permit only. All State regulations apply in addition to the following Refuge specific regulations. A total of 180 hunt permits will be issued (45/day for 4 days). An additional 20 stand-by hunters will be drawn. Hunt areas will be assigned on a random basis, with first priority going to hunters with a Zone #10 (antlerless) permit. If the hunt quota is not met, a 5th hunt day may occur on Monday, December 6.

Application procedures: Send a 3 1/2 x 5 card with your name, address and Massachusetts hunting license number and a selfaddressed stamped envelope to the Refuge. Only one entry per person. Applications must be postmarked by October 1 and received prior to the drawing. Only applicants sending a self-addressed stamped envelope will be notified.

**Season:** Hunting will be permitted daily from Monday, November 29 - Thursday, December 2. Hunting hours will be from 1/2 hour before sunrise to sunset. If the hunt quota is not met, a 5th hunt day may occur on Monday, December 6.

**<u>Bag Limit</u>**: A total of two deer may be harvested. Antlerless deer may only be harvested if hunter possesses a Zone #10 State permit. Hunters are encouraged to apply for and hunt with a Zone #10 permit. All deer taken, as well as entrails, must be checked-in at the Refuge Check Station located at Sub-Headquarters.

**Equipment:** Only .20 gauge or larger shotguns permitted. Portable, non-damaging tree stands are permitted.

**<u>Permit Fee</u>**: A non-refundable \$20 fee is required for permit. U.S. Senior Citizens (62+) and permanently disabled individuals are eligible for a 50% discount. Fee must be paid at the hunter orientation meeting. Stand-by hunters must pay fee prior to hunting on selected day.

**Lottery:** A random computer or hand-drawn lottery will be conducted on Monday, October 18 at 3:30pm. The lottery will be open to the public and held at the Refuge headquarters.

Orientation: A mandatory hunter orientation/safety meeting will be held on Saturday, October 30. All hunters, including standbys, must attend.

- Note: Individuals with disabilities are encouraged to contact the Refuge headquarters for additional information.
- Note: Applications for State Zone #10 Antlerless Permit must be sent to State by 8/5/93.

	If the deer quota has not been reached by COB on 12/2, deer hunting will be permitted on 12/6. Hunters interested in hunting on 12/6 must call the refuge on 12/3 between 8 - 10AM. Hunters will be selected on a first come, first serve basis. Those hunters who have not gotten their quota of deer may participate in the hunt on 12/6. (An exit poll of deer hunters during the previous wk will give us some indication if there is enough interest to conduct the hunt on 12/6.

EQUIPMENT:	Shotgun 20 gauge or larger loaded with slugs only

HUNTING ZONES: Two zones (instead of four as in past years) The specific area for each zone is yet to be determined.

- PARKING: Specific parking lots will not be assigned (as in past years) BUT hunters not adhering to the parking regulations will have their refuge permit pulled, receive a parking fine, and their car will be towed. Lot size will be predetermined by staff based on safety factors.
- PUBLIC USE: The Refuge will be closed from sunset on 11/28 until Noon on 12/3 and again from sunset on 12/5 until Noon on 12/7. (Visitors will be able to use the refuge on the weekend).
