Mr. HASKELL (for Mr. JACKSON) (for himself and Mr. FANNIN) (by request) introduced the following bill; which was read twice and referred to the Committee on Interior and Insular Affairs

A BILL

To designate all of the Anaho Island National Wildlife Refuge, Washoe County, Nevada, as wilderness.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That in accordance with section 3 (c) of the Wilderness Act
- 4 of September 3, 1964 (78 Stat. 890, 892; 16 U.S.C.
- 5 1132 (c)), all lands in the Anaho Island National Wildlife
- 6 Refuge, Nevada, which comprise approximately seven hun-
- 7 dred and forty-seven and seventy-three one hundredth acres
- 8 and which are depicted on a map entitled "Anaho Island
- 9 Wilderness Proposal", dated February 1973, are hereby
- 10 designated as "wilderness". The map shall be on file and

- 1 available for public inspection in the office of the Bureau of
- 2 Sport Fisheries and Wildlife, Department of the Interior.
- 3 Sec. 2. As soon as practical after this Act takes effect,
- 4 a map of the wilderness area and a description of its boundary
- 5 shall be filed with the Interior and Insular Affairs Commit-
- 6 tees of the United States Senate and the House of Repre-
- 7 sentatives and such map and description shall have the same
- 8 force and effect as if included in this Act: Provided, however,
- 9 That correction of clerical and typographical errors in such
- 10 map and description may be made.
- 11 SEC. 3. The wilderness area designated by this Act shall
- 12 be known as the Anaho Island Wilderness and shall be ad-
- 13 ministered by the Secretary of the Interior in accordance
- 14 with the provisions of the Wilderness Act governing areas
- 15 designated by that Act as "wilderness" areas, and where
- 16 appropriate any reference in that Act to the Secretary of
- 17 Agriculture shall be deemed to be a reference to the Secre-
- 18 tary of the Interior.
- 19 SEC. 4. Subject to all valid rights existing on the date of
- 20 enactment of this Act, lands designated as "wilderness" by
- 21 this Act are hereby withdrawn from all forms of appropria-
- 22 tion under the mining laws and from disposition under all
- 23 laws pertaining to mineral leasing and all amendments
- 24 thereto.
