SAMMS number of Alternate Facility Type.
Alternate Facility Type. Trail lies on a feature such as a levee, dam, administrative road or bridge, which has a separate SAMMS number.

The average grade of the trail (\%). The average of five measurements for trails less than two miles and ten measurements for trails equal to or greater than 2 miles.

The average cross-slope of the trail (\%). The average of five measurements for trails less than two miles and ten measurements for trails equal to or greater than 2 miles.

A small dam constructed across a drainage ditch, swale, or channel to lower the speed of concentrated flows.

Subjective rating of trail based on Facility Condition Index (FCI):
FCI </= - . 01 = Excellent
FCI . 02 - . 05 = Good
FCI . 06 - . 10 = Fair
FCI . 11 - . $20=$ Poor
FCI > - . 20 = Failed
Retaining wall.
The value of an asset determined by the estimated cost of replacing it.

Deficiency Type: Trail Structure, Drainage, Erosion, Obstacle, Trail Location, Other.

Maintenance that was not performed when scheduled.

Unique identifier for each trail section: Org Code-Trail Number-Section Number.

## DM/CRV

Grouped features include non-unique signs (mileposts, interpretive signs, species identification, etc.), water bars, check dams, steps, drain and drainage dips. For any given grouped feature, a GPS point and photo are taken for the first occurrence only and the total number of features in the group are entered into the "quantity" field of the data dictionary.

Type of accessibility information available at trailhead: brochure, sign or other.

Item on which the "Action" (see above) will be performed.

Managed use of the trail: HIKE, BIKE, NSPC (nonspecified), PACK, POR (portage), SNOWSHOE, XSKI (cross-country ski), OTHER.

Distance of a trail feature or deficiency from the Trailhead.

Log footbridge used in area of poor drainage.
Boardwalk, Turnpike, Puncheon.

Trail Class: I-V (see Appendix ? for trail class descriptions).

Trail Designation: Standard (Std), National Historic Trail (NHT), National Recreation Trail (NRT), National Scenic Trail (NST).

Trail tread elevated with dirt, rock or other aggregate from parallel side ditches and held in place by logs.
